ORDINANCE NO. LU-2014- 4

**AN ORDINANCE REVOKING ORDINANCE 13-LU-42 WHICH PROHIBITED THE OPERATION OF MARIJUANA CULTIVATION FACILITIES, MARIJUANA PRODUCT MANUFACTURING FACILITIES, MARIJUANA TESTING FACILITIES OR RETAIL MARIJUANA STORES WITHIN THE UNINCORPORATED BOUNDARIES OF SAGUACHE COUNTY, STATE OF COLORADO**

**WHEREAS**, pursuant to § 30-15-401, C.R.S., the Board of County Commissioners of Saguache County, Colorado (hereinafter the "Board"), has the general enabling power to adopt ordinances for the control or licensing of those matters of purely local concern, and to do all acts and make all regulations which may be necessary or expedient for the promotion of the health, safety and welfare of the present and future residents of Saguache County; and

**WHEREAS**, on September 17, 2013, the Board of County Commissioners enacted Ordinance 2013-LU-42, which prohibited the Operation of MARIJUANA CULTIVATION FACILITIES, MARIJUANA PRODUCT MANUFACTURING FACILITIES, MARIJUANA TESTING FACILITIES OR RETAIL MARIJUANA STORES WITHIN THE UNINCORPORATED BOUNDARIES OF SAGUACHE COUNTY, STATE OF COLORADO; and

**WHEREAS**, on March 11, 2014 the Saguache County Board of Commissioners approved and adopted Resolution LU-2014-3, which authorized the sale and processing of retail marijuana in the unincorporated boundaries of Saguache County, State of Colorado, subject to permitting and regulatory compliance; and

**WHEREAS**, the Board of County Commissioners deem it appropriate and in the best interests of the citizens of Saguache County to revoke Ordinance 13-LU-42.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of County Commissioners of Saguache County that Saguache County Ordinance 13-LU-42 is hereby revoked as of this date.

**SAFETY CLAUSE:**


The Board hereby finds, determines and declares that this Ordinance is necessary for the health, safety and welfare of the citizens of Saguache County, Colorado.

**PUBLICATION AND EFFECTIVE DATE:**

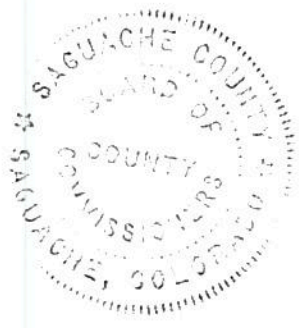
